Mr. VanArsdel made a motion to approve the architect and the site plans as presented. Mr. Shepherd made a second to the motion and the motion passed.

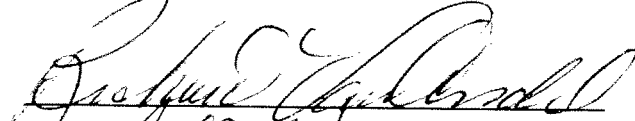
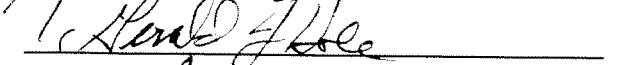
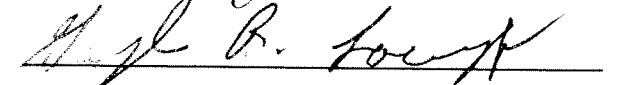

**OTHER BUSINESS**

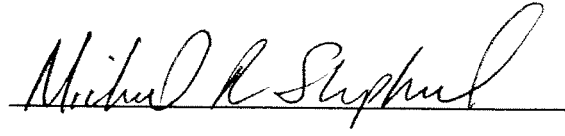
The Board heard comments and reports from Board members, Principals, Transportation, and NMTA.
