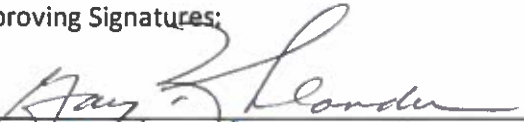

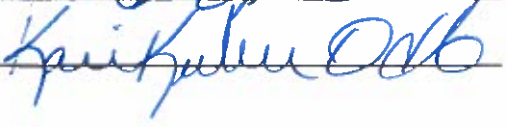
The Board heard comments from fellow Board members and principals.
